

VISITING GUIDELINES 2021

To ensure our handlers' and guests' safety in the New Normal, please take note that no walk-ins will be accommodated at the Hound Haven K-9 Retirement & Rehabilitation Center. In the time being, we do NOT accommodate field trips, team building activities, and other events involving large groups. As much as we'd like to share the Center to as many people as possible, we're putting everyone's health and safety first.

Planning Your Visit

- 1. Schedule your visit to the Center by filling out our [LINK: visiting form]. No walk-ins will be accommodated.
- 2. Only a maximum of four (4) guests per visiting group. Each guest must not be below 16 or over 65 years of age.
- 3. For contact tracing, each guest is required to fill out the <u>Health Declaration Form</u> prior to their visit.
- 4. To help with the upkeep of our center and support our operations, our updated grounds fee as of July 2020 is PHP500 per head. The amount should be settled online through any of the following channels prior to your visit. (IMPORTANT: Please wait for our initial confirmation of your time slot before making any payment.)

- 5. Visitors with a negative antigen or RT-PCR test result may stay at the office / holding area. All other guests are limited to the open grounds and kennel area. Email your test results to **contact@houndhavenph.org** 72 hours before your scheduled visit.
- 6. Wait for our email confirmation.

During Your Visit

- 7. Our address is 353 Pinaglagarian St., Pulong Yantok, Angat, Bulacan. You will find us on Waze or Google Maps as "Hound Haven Philippines."
- 8. All visitors are required to wear a face mask at all times. No face mask, no entry to any part of the Center.
- 9. Please bring your own drinking water.

Visiting with Your Pet

You and your dogs are welcome at our center, provided:

- 10. That owners will inform that he/she will be bringing a pet along prior to their visit.
- 11. Owners should present their pets' updated vaccination records prior to their visit or at the site.
- 12. Pets may only use the common grounds. The kennel and activity areas are only for K-9 residents that are undergoing a special rehabilitation program.
- 13. Owners will be held responsible for their pets and their pets' behaviors at the site.

If you have read and understood these guidelines, you may now proceed to scheduling your visit by filling out this form.
